**Notice of New U.S. and Canada-origin Tariff Minimums and Security Surcharges Effective January 1, 2009**

Please be aware that Continental Airlines Cargo is increasing its U.S. and Canada-origin domestic and international tariff minimums, effective January 1, 2009 (see attachment). These rate minimums have not been adjusted in a number of years and are being brought to competitive levels.

Further, as a result of mandated security measures, Continental will increase its security surcharges from the United States, Canada and Israel effective January 1, 2009. The second attachment illustrates the new security surcharges.

**NEW SECURITY SURCHARGES EFFECTIVE January 1, 2009**

Continental Airlines will implement an increase to its security surcharges on all international and domestic freight and QUICKPAK shipments effective January 1, 2009 from the U.S., Canada and Israel. Continental will assess security surcharges as follows:

<b>From</b>	<b>To</b>	<b>Surcharge</b>
United States*	United States* and Canada	0.06 USD per pound 10.00 USD minimum applies
United States*	All international destinations except Canada	0.20 USD per kilogram 10.00 USD minimum applies
Canada	United States*	0.06 CAD per kilo 10.00 CAD minimum applies
Canada	All Other Destinations	0.15 CAD per kilogram 10.00 CAD minimum applies
Israel	All destinations	0.15 USD per kilogram

- The security charge is a separate charge, (SC), that is reflected as a due carrier fee.
- The security surcharge is calculated using the shipment's actual weight.
- The security surcharge is applicable to both freight and QUICKPAK.
- The security surcharge is applicable to all interline shipments.
- On domestic shipments, the Federal Excise tax of 6.25 percent is applicable.
